SACRAMENTO — California is poised to create a new system to get severely mentally ill people into treatment called CARE Court, which family members of

people with psychotic disorders say they hope will help them save their loved ones from suffering on the streets.

California lawmakers passed the legislation to create CARE Court on Wednesday, sending it to Gov. Gavin Newsom, who sponsored the bill and is expected to sign it soon.

The measure, <u>SB1338</u>, will create a new way for family, community members, probation officers and others to refer people with severe mental illness into treatment. Under the system, judges would order people to participate in treatment plans and require counties to provide services to them.

The bill was amended to take effect in two waves instead of all at once. First, an initial group of counties representing at least half of California's 40 million residents will start the program by July 2023. The rest will start the program by July 2024.

In response to <u>worries from local governments</u> that the proposal didn't include adequate money to support the new system, Newsom and lawmakers added \$57 million in funding through the state budget..."

# ELIMINATING WEEDS AND ALGAE NEEDS A NEW APPROACH BASED ON CHANGING CONDITIONS – regulators need to "improvise, adapt and overcome" and let us fix the problem

This summer by all accounts has produced invasive weeds, algae, and bad smells around the South Shore. Some people say not to worry. It will go away. Others like me are worried, because I am aware of toxic algae issues elsewhere in the State as reported widely in the media. Local social media is replete with comments about the situation, and most of them are not good.

Some people blame the TKPOA for the condition because they say the Keys should never have been built in the first place. *However*, most people who live in the Keys today purchased homes a long time after the Keys were built by the developer. I am told, as well, that until 1997, the TKPOA operated a treatment plant to clean the waters in the lagoons and Lake Tallac. The plant site and pumps still exist at the end of Texas Avenue.



While I have my concerns with the current Board of TKPOA over the drinking water issue, the TKPOA is not to blame for the snail pace effort being made to address the invasive weeds. The invasive weeds and algae issues are being addressed here together.

What has happened is that the regulatory agencies in the Basin responsible for water quality, the LRWQCB and TRPA decided to set standards for water quality after chemical treatment of the weeds, which are well above drinking water standards. Meeting this standard, if possible, will take time, money, and years. Well, the reality is that the invasive weed conditions and now algae are getting worse, not better. What do regional officials do to respond to changing conditions that demand a more aggressive approach to removal you ask, nothing. In fact, with one exception by Julie Regan of TRPA, officials (including the El Dorado County Health Officer) regulatory and health officials do not respond to the questions of safety of the growing weed and algae problems. It is their job to respond! All of us want to know.

Regional officials need to recognize the changing and worsening conditions of the weeds and Lake and make appropriate changes to address the changing conditions. Regional officials need to "improvise, adapt, and overcome" to changing conditions and the City and County elected officials on the TRPA Board need to demand this happens. Do not just sit there, do something! This is not business as usual even though I do appreciate the support of these agencies for allowing exploration of a treatment process that is still undefined.

I suspect and have voiced on several occasions that after years of study, millions of dollars spent, and worsening of the problem, regulators and TKPOA will decide that the water treatment system discarded in 1997 is not such a bad idea. *They need to energetically examine this solution now*.

Regional regulators need to adapt to new conditions. Do not blame this matter on the TKPOA members or Board.

## WE NEED COMMON SENSE WHEN BUDGETING- spend the money first where it is most needed.



I know a lot about local government budgeting. I presented over 35 balanced budgets to city councils in my career. I know that budgeting can be difficult, especially in financially stressed times. However, elected, and appointed leaders need to learn something that households do every day. Live within your budgets. Set priorities of those things that are the most urgent and necessary, and then budget funds to address the highest priorities. This is only common sense. Let me give you an illustration. City streets by and large are

a mess. They are not maintained (i.e., potholes filled, cracks in the streets filled, and slurry seal). on an annual basis and proper drainage of our roads is hard to find. The approach the City is taking is to allow the streets to crumble and then pronounce that a few of them will be reconstructed one day. If the streets were regularly maintained and repaired on a City-wide basis, reconstruction would not be needed for a much longer time. The cost of maintenance is less than the cost to reconstruct. Caltrans does an excellent job fixing and repairing our highways in Tahoe, and we can learn from that example.

I like and appreciate new bike lanes being installed. I am a rider and enjoy a nicely paved area unless I am in the mountains. However, the existing road system needs to be fixed first and then look at what monies might be available for bike trails that themselves are supposed to be maintained.

This is only common sense, and by fixing the roads we will experience less wear and tear on our suspension system whether the vehicle is electric or not.

Don't misunderstand me on this one. The problem is not with our street repair crew. They want to do an excellent job. They just need the funds for proper staffing, materials, proper machinery, and training.

## TALKING ABOUT FIRE SAFETY ONLY AT ELECTION TIME DOESN'T CUT IT ANYMORE – hold State and Federal officials accountable.

As we bet closer to election time, a lot of people are talking about making us fire safe. The fact is, for the most part, that this talk subsides after the election, because no policy maker wants to empower City staff to tackle the dangerous fire conditions that exist on CTC and USFS lands inside the City limits. Elected officials past and present have waited too long and allowed these large landowners to keep their lands in an unsafe condition. But they will tell you, "we are all getting along so well." Getting along is not getting the job done to make our City fire safe. The City Council must demand of State and Federal landowners that they regularly see that their parcels in the City limits are fire safe, and our residents will see a more fire safe city.



#### MICRO GIFT TO DOUGLAS COUNTY?

In a recent briefing for candidates for City Council, a question was asked who is paying for the new Micro-Transit System that started up and runs in Douglas and El Dorado County. Private parties and the City of South Lake Tahoe are paying the bill. Douglas County that receives a lot of benefit from the new development is paying \$0. Frankly, I would rather see the City's \$150,000 per year contribution to this system be allocated to better maintain City street every year especially if Douglas County won't pay for their own system,

In general, I like the idea and practicality of smaller demand responsive busses instead of the LA type huge busses seen riding with few passengers around town, but it is only fair to expect that Douglas County pay its fair share.

l asked the Douglas County Manager the following question on 9-1-22.



Dear Mr. Cates:

Thank you for your service to Douglas County. I enjoy many of your services there.

I am running for a seat on the South Lake Tahoe City Council. As a former City Chief Executive, I know that governance in the Tahoe

Region is different and challenging. The reward is of course the beautiful place where we live and recreate.

I attended a City Council Candidate briefing yesterday put on by City management staff, and I learned that among many parties, Douglas County is the only governmental agency that does not contribute funds for the operation of the newly established micro-transit buses running on both sides of Stateline.
